#### **DISCUSSION ITEMS**

1. **Orvananos/Grimm** – Application seeking approval to regrade front yard, install diffusion well, and construct a garage on a 0.8 acre parcel located at 862 Sound Shore Road, Riverhead, with said parcel being more particularly described as SCTM No. 600-8-1-12 and located within the Residence A40 (RA40) zoning use district.
2. **National Grid – Manorville Gas Main Replacement** – Application seeking approval to replace 2,202 linear feet of 6 inch steel gas main with 2,202 linear feet of 8 inch gas main. The gas main will be installed within the road shoulder via trenching, except for approximately 200 linear feet which will be installed under the Peconic River via horizontal directional drilling. The work is being performed within the vicinity of River Road and David Terry Road, Manorville.
3. **Femmino Residence** – Application seeking approval for minor alterations to an existing single story frame dwelling, and to reconstruct a ±250 sq. ft. frame garage, a ±480 sq. ft. dilapidated building, as well as patios, walkways, and a stone wall by the Peconic River. The subject property is a 0.268 acre parcel, located at 809 West Main St., Riverhead, with said parcel being more particularly described as SCTM No. 600-124-3-13.1.

#### **HOLDOVER APPLICATIONS**

1. **Elia** – **No new information at this time.** Application to legalize an existing deck on a parcel located at 103 Meetinghouse Creek Road, Aquebogue, with said parcel being more particularly described as SCTM No. 600-113-2-9 and located within the Residence B-80 (RB80) zoning use district.

2. **Duggan** – **No new information at this time** - Discussion of an application to reconstruct and expand the existing shoreline access/dock along the shoreline of Reeves Creek. The subject parcel, 83 Leafy Way, Aquebogue, more particularly described as SCTM No. 600-113-4-3, is a 0.49 acre site located within the Residence B-40 zoning use district.
