AWARDS BID FOR FIVE (5) FORD CROWN VICTORIA POLICE INTERCEPTOR VEHICLES FOR USE BY THE TOWN OF RIVERHEAD POLICE DEPARTMENT

Councilman Wooten offered the following resolution,

which was seconded by Councilwoman Giglio

WHEREAS, the Town Board of the Town of Riverhead authorized the issuance of a Request for Proposals for Five (5) 2011 Ford Crown Victoria Police Interceptor Vehicles for use by the Town of Riverhead Police Department by Resolution #32 adopted on January 4, 2012; and

WHEREAS, pursuant to the terms of the Request for Proposals, each proposal must comply with the instructions in the Notice to Bidders and required that all proposals be submitted on or before January 19, 2012 at 11:05 a.m.; and

WHEREAS, the Town did receive one response to the Request for Proposals from a qualified vendor, to wit: Riverhead Ford Lincoln, 1419 Old Country Road, Riverhead, NY 11901; and

WHEREAS, the Town reviewed the bid for the Five (5) 2011 Ford Crown Victoria Police Interceptor Vehicles for use by the Town of Riverhead Police Department and after serious consideration the Town Board has determined that it is in the best interests of the Town of Riverhead to award the bid to Riverhead Ford Lincoln, subject to availability, for up to Five (5) 2011 Ford Crown Victoria Police Interceptor Vehicles.

NOW THEREFORE BE IT RESOLVED, that the Town Board awards Riverhead Ford Lincoln the bid for Five (5) 2011 Ford Crown Victoria Police Interceptor Vehicles, subject to availability and, as set forth in the bid specifications, the Town reserves the right to increase the quantity of ordered units within ninety days or accept alternative vehicles offered in the bid to meet the quantity of requested units; and be it further

RESOLVED, that the Supervisor is authorized to execute all necessary documents to effectuate the order, purchase, delivery of the vehicles described in the bid for 2011 Ford Crown Victoria Police Interceptor Vehicles submitted by Riverhead Ford Lincoln; and be it further

RESOLVED, that the Town Clerk is hereby directed to forward a copy of this resolution to Riverhead Ford Lincoln, 1419 Old country Road, Riverhead, NY 11901 and Riverhead Police Chief David J. Hegermiller, Town Accounting Department and Town Purchasing Department; and be it further

RESOLVED, that all Town Hall Departments may review and obtain a copy of this resolution from the electronic storage device and, if needed, a certified copy of same may be obtained from the Office of the Town Clerk.
