NOW, THEREFORE, BE IT RESOLVED, that the Town Board authorizes the Town Clerk to publish and post a notice of Request for Proposals for an aquarium or similar economic growth generator in the following publications on the following dates: New York Times Newspapers, Sunday, September 21, 1997; The Wall Street Journal Newspapers, Thursday, September 18, 1997; and an aquarium-specific trade publication to be determined, for publication in its next edition.
