

**NOTICE OF ELECTION**

Manorville Fire District  
in the Towns of Brookhaven and Riverhead, New York

**NOTICE IS HEREBY GIVEN** that pursuant to a resolution of the Board of Fire Commissioners, an election of the qualified voters of the Manorville Fire District in the Towns of Brookhaven and Riverhead, County of Suffolk, State of New York, will be held at the firehouse located at 14 Silas Carter Road, Manorville, NY 11949 on the 15th day of January, 2019, between the hours of 6 p.m. and 9 pm. to vote on whether to approve the following resolution adopted by such Board of Fire Commissioners:

**RESOLUTION FOR FINANCING OF VEHICLES:**

**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE MANORVILLE FIRE DISTRICT, TOWNS OF BROOKHAVEN AND RIVERHEAD, SUFFOLK COUNTY, NEW YORK (THE "DISTRICT"), AUTHORIZING THE FINANCING OF THE PURCHASE OF THREE VEHICLES AND THE TRADE OF TWO VEHICLES: THE PURCHASE PRICE AND FINANCING OF THE THREE VEHICLES TOTAL BEING A MAXIMUM OF \$1,500,000 PRINCIPAL; APPROPRIATING SAID AMOUNT THEREFOR; AND AUTHORIZING THE FINANCING BY A COMBINATION, IN FULL OR IN PART, OF ANY AND ALL OF THE FOLLOWING: BY ISSUANCE OF A SERIAL BOND OR STATUTORY INSTALLMENT BOND OR BY INSTALLMENT PURCHASE AGREEMENT UP TO \$650,000; AND TO ISSUE BOND ANTICIPATION NOTES IN CONJUNCTION WITH THE ABOVE, FOR UP TO FIVE CONSECUTIVE YEARS; USE OF UP TO \$350,000 FROM A CAPITAL RESERVE FUND; AND APPROVING THE SALE/TRADE OF TWO 1993 PIERCE PUMPER WITH A VALUE OF MORE THAN \$100,000 EACH AS PART OF SUCH PURCHASE; INCLUDING FINANCING AN ADDITIONAL AMOUNT IF NEEDED THE COST OF THE FINANCING INCLUDING BOND COUNSEL FEES.**

That pursuant to Local Finance Law Section 80, the validity of such bonds or notes or any bond anticipation notes issued in anticipation of the sale of such bonds may be contested only if such obligations are authorized for an object or purpose for which the fire district is not authorized to expend money; or if the provisions of law which should be complied with as of this date are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty days after the date of such publication; or such obligations are authorized in violation of the provisions of the constitution.

All persons registered to vote in the district and residing in the district for at least thirty (30) days prior to the day of the vote may vote in such election.
