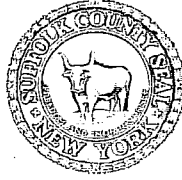

REQUEST FOR WRITTEN COMMENTS ON PROPOSED SHELLFISH AQUACULTURE LEASE ASSIGNMENT

Notice is hereby given that the Suffolk County Department of Economic Development & Planning has received one Lease Assignment Application requesting the assignment of a Shellfish Aquaculture Lease in Peconic Bay pursuant to Local Law 25-2009, *A Local Law Establishing the Suffolk County Shellfish Aquaculture Lease Program in Peconic Bay and Gardiners Bay* (Article II of the Suffolk County Code, §475). This lease site is located within the adopted Shellfish Cultivation Zone and was initially leased during the 2017 Lease Application Cycle.

Pertinent data and information from the Lease Assignment Application, including the name of the current leaseholder, the name of the proposed assignee, respective SCALP # and the location (center point coordinates) of the lease site are contained in Attachment A of this Public Notice.
