The Highway Committee reporting on the matter of the water drain through the property of Mr. Clyde Tooker on Riverside Drive, advised the Board that if two catch basins are constructed on either side of Riverside Drive and a curb and gutter are built on the north side of Mr. Tooker's lot, he will give the Town a permanent easement through his property to the River.

The Highway Committee reporting upon the easement through the property of Mrs. Jennie S. Conklin near Sweezy Avenue, advised the Board that she has set a price of \$500.00 for a permanent easement.

Mrs. Hallock Luce addressed the Board in regard to the appointment of a Life Guard at the Beach at Pier Avenue, during the Red Cross swimming campaign from June 29th to July 20th, 1936, stating that during that time many people are at the Beach which creates a dangerous situation.

On motion made by Justice Kelly and seconded by Justice Luce it was RESOLVED that Horace Corwin be and he hereby is appointed Life Guard at the Beach at Pier Avenue and it is further

The Town Board convened as a Board of Audit and examined the Town bills for the month of June, 1936.
