Harrison H. Corwin, Wm. R. Duvall Water Commissioners and Dr. A. G. Terrell, Health Officer were present at this meeting.

Dr. A. G. Terrell presented a complaint from the State Health Department in relation to the condition of the privies in the vicinity of the Riverhead Water plant and also explained to the Town Board what steps should be taken to satisfy the complaint.

On motion made, seconded and carried Wm. L. Miller was appointed a committee to carry out the plans or requirements of the State Health Department in relation to sanitary conditions within 500 feet of Water District property.

On motion made, seconded and carried the Riverhead Water district Commissioners were authorized to purchase property west of Present Holdings.

On motion made, seconded and carried Justice Burnside was appointed a committee to negotiate for property and report to the Water Commissioners.

added The Amendments of the State Health Department were ~~ordered~~ to the Health regulations of the Town of Riverhead and were ordered printed and published according to law.

On motion made, seconded and carried the Water Commissioners were authorized to hold four meetings a month.

On motion made, seconded and carried the annual report

of the Supervisor's Highway Account to Dec. 28th, 1920 was approved and ordered to be inserted in the minutes.
