Minutes of a meeting of the Town Board of the Town of Riverhead held in the Town Hall on Wednesday, August 8, 1945 at 2:00 P.M.

Minutes of a meeting of the Town Board held on July 25, 1945 were read and on motion and vote were duly adopted.

A communication was read from John Bilski tendering his resignation as Police Patrolman of the Town of Riverhead, effective as of August 15, 1945. The communication was ordered placed on file.

On motion made by Justice Yousik and seconded by Justice Smith it was Resolved that the resignation of John Bilski as Police Batrolman of the Town of Riverhead be and the same is hereby accepted, effective as of August 15, 1945. The vote, Justices Warner, Yousik, Leonard and Smith Yes, Supervisor Kelly Yes. Total Vote Yes 5, No O. The resolution was thereupon declared duly adopted.

A communication was read from the Board of Supervisors stating that it had fixed Monday, November 26, 1945, as the date of the meeting of that Board at which taxes for the next fiscal year will be levied. The communication was ordered placed on file.

The Supervisor's report for the month of July, 1945 was submitted to the Board and on motion and vote was accepted and ordered placed on file.

The Police and Welfare reports for the month of July, 1945 were submitted to the Board and on motion and vote were ordered placed on file.

On motion made by Justice Warner and seconded by Justice Leonard it was Resolved that the Board of Assessors be authorized to employ a temporary Clerk, at their discretion, salary fixed at \$4.00 per day. The vote, Justices Warner, Yousik, Leonard and Smith Yes, Supervisor Kelly Yes. Total Vote Yes 5, No O. The resolution was thereupon declared duly adopted.

On motion made by Justice Warner and seconded by Justice Smith it was Resolved that Louise E. Downs be and she hereby is appointed Junior Clerk to the Receiver of Taxes of the Town of Riverhead for the duration of the war, salary fixed at \$4.00 per day. The vote, Justices Warner, Yousik, Leonard and Smith Yes, Supervisor Kelly Yes. Total Vote Yes 5, to 0. The resolution was thereupon declared duly adopted.

A communication was read from J.J.Darcy, District Engineer of Public Works advising the Board that the Law had been amended in regard to making Town Highways one-way streets and requesting the Board to consider the advisability of making Roanoke Avenue, Town of Riverhead a one-way

street. The communication was referred to the Chief of Police for study and report.

A communication was read from Mr. Benjamin J. Case favoring the c creation of a Garbage Collection District. He also favored back yard collections and that the District when created be placed under the supervision of the Highway Department. The communication was ordered placed on file.

On motion made by Justice Leonard and seconded by Justice Warner it was Resolved that the Long Island Lighting Company be authorized to install one 80 C.P. street light on Pole #5 on Kratoville Ave. in the Riverhead Lighting District. The resolution was adopted by the unanimous vote of the Board.

On motion made by Justice Leonard and seconded by Justice Smith it was Resolved that the Long Island Lighting Company be authorized to install one 80-C.P. street light on Pole #5 on Sixth Street in the South Jamesport Lighting District. The resolution was adopted by the unanimous vote of the Board.

The matter in regard to the contract between the Riverhead Fire District and the Riverhead Fire Protection District was discussed by the Board. It was the unanimous opinion that the Town Board and the Board of Fire Commissioners meet together and go over the matter relative to the requested increase of the amount of the contract.

On motion made by Justice Warner and seconded by Justice Leonard it was Resolved that Wallace Seaman Jr. be appointed Police Patrolman for the Town of Riverhead for the duration of the war and that his salary be fixed at the rate of \$2000.00 per annum, payable semimonthly. The vote Justices Warner, Yousik, Leonard and Smith Yes, Supervisor Kelly Yes. Total Vote, Yes 5, No O. The resolution was thereupon declared duly adopted.

The Town Board then convened as a Board of Audit and examined all Town bills to date.

There being no further business on motion and vote the meeting adjourned to meet on Wednesday, August 22, 1945 at 2:00 P.M.
