Begins at the point of intersection of the easterly line of District No. 5 and the southerly line of Long Island Sound, thence easterly following the shore of Long Island Sound to a point which would be the continuation northerly of the centre line of West Lane, thence following said line to Sound Avenue, thence following the centre line of West Lane southerly to the centre of the Main Road, thence westerly along the centre of the Main Road to the road leading to the Aquebogue Depot, thence southerly along the centre of the Aquebogue Depot Road and a line in continuation thereof to the southerly line of the Town of Riverhead, thence westerly along the southerly line of the Town of Riverhead to a point which would be the continuation southerly of the easterly line of Fisher's Bakery property, thence following said line notherly to the centre line of Main Street, thence easterly along Main Street to the centre of East Street, thence along the easterly boundary of District No. 5 following a line along the centre of East Street, Long Island Railroad, Union Street, Northville Turnpiks, Sound Avenue and Penny's Road to the place of beginning.
