

Minutes of the meeting of the Town Board of the Town of Riverhead, held in the Town Office, on Wednesday, May 13th. 1931 at 2 P. M.

Charles O. Downs, Town Superintendent of Highways was present.

The minutes of the meeting of the Town Board, held April 29, 1931 were read and on motion and vote adopted.

A communication received from J. Harry Saxstien, Attorney, advising the Board that the Kirkland Bill had been vetoed by the Governor, was read and ordered placed on file.

A report from Miss Jacobs, Town Nurse, was received and ordered placed on file.

An opinion of Attorney Syrena Stackpole was read and ordered placed on file.

A petition received from residents of Wading River, requesting that Selden Heatley be appointed Special Constable was presented and ordered filed.

Mr. Walter F. Barnes, President of the Suffolk County Historical Society, addressed the Board requesting that curbs and gutters be constructed around the Historical Society Property.

Lewis C. Austin, representing the Civic Club of Riverhead, addressed the Board and requested that the Petition calling for an election to create a Police District within the Town of Riverhead, be filed.

On motion duly made, seconded and carried it was Resolved That Attorney N. O. Petty, be retained by the Town Board to examine the petition asking for an election to create a police district and to advise the Board of the proper steps to be taken in this matter.

Attorney J. Harry Saxstien, representing John H, Skinkaytis of South Jamesport, addressed the Board and requested that the Board make some decision relative to Green Street at South Jamesport, N.Y. It was decided to hold this matter over until the next meeting of the Town Board when a decision would be made by the Board.

Justice E. M. Frederick advised the Board that taxpayers of South Jamesport requested that twelve street signs be purchased and installed at South Jamesport, N.Y.

On motion duly made, seconded and carried it was Resolved That twelve street signs and standards be purchased and installed at South Jamesport.

On motion duly made, seconded and carried it was Resolved That Forrest G. Downs, Receiver of Taxes be and he hereby is authorized to employ a clerk for a period of thirty five days to assist in checking the tax rolls before turning them over to the County Treasurer and be it further Resolved That the compensation of said clerk be and the same is fixed at \$5.00 per day.

On motion duly made, seconded and carried it was RESOLVED That the Supervisor and the Town Clerk be and they hereby are authorized and directed to issue a new certificate of indebtedness in the amount of \$2,190.47 to replace certificate of indebtedness of like amount held by the Suffolk County Trust Company, for the Fishel Avenue Sidewalk District.

There being no further business, on motion and vote the meeting adjourned.
