Minutes of a meeting of the Town Board of the Town of Riverhead, held on Wednesday, August 13th 1930 at 2 P.M.

Tharles O. Downs, Town Superintendent of Highways was present.

The minutes of the meeting of the Board held on July 30th 1930 were read and on motion and vote duly adopted.

There was some discussion as to whether it was advisable or not to create a Police District at this time but no definite action was taken on the matter.

Town Superintendent of Highways Charles O. Downs reported that it would cost about \$1000.00 to put in new pipe andraise a bulkhead near the property of Frank Raciniewski at South Jamesport, and that to place a curb and gutter on the south side of Elton Street from the corner of Upper East Street to private road about 150 feet east of Roanoke Avenue would cost about \$600.00. It was decided to consider these items when the budget is made up for the year 1931. The Superintendent of Highways was requested to have the taxpayers effected by the curb and gutter on Elton Street present at the next meeting of the Board.

Charles O. Downs, Town Sup't. of Highways, advised that with the money available for curb and gutters on Main Street including grading and lowering sidewalk, he was of the dpinion that this work could be done from enjamin Place to Maple Avenue.

The opinion of the Board was that this work could be done by the Superintendent of Highways without putting the work out for bids. Supervisor Homan appointed Justice Conklin work out for bids. Supervisor Homan appointed Justice Conklin and Charles O. Downs, to serve with him as a committee to see and Charles O. Downs, to serve with him as a committee to see and Charles of the Methodist Church and see if the abuttment the Trustees of the Methodist Church and see if the abuttment of East Avenue and Main Street could be eased by obtaining a strip of land from the church property.

Justice Miller advised that he had received numerous requests from the owners of property near the Town Property at Wading River Beach, that the Town have signs erected to show

where the Town property ends and the private property begins.

On motion duly made, seconded and carried it was Resolved That the Superintendent of Highways be and he hereby is authorized to have signs painted and erected at Wading River Beach marking the boundaries of the Town property, and advising that the property bordering the Town property is private property.

Justice Conklin advised that twelve feet of land may now be obtained from the Polish Church property to widen out the extension of Marcy Avenue north of Pulaski Street so that this extension may be accepted as a Town Highway.

On motion duly made, seconded and carried it was RESOLVED That Attorney R. Condon Smith be retained by the Town to draw up the necessary releases and consent in connection with the Marcy Avenue extension in order to make said extension acceptable as a Town Highway.

Mr. S.D Maud, a representative of the Davey Tree Expert Company addressed the Board advising of trees within the Village that were dangerous. Mr. Maud was requested to take this matter up with Sup't. of Highways Charles O. Downs who was requested to report at the next meeting of the Town Board the result of their findings.

Supervisor Homan appointed Justices Burnside and Conklin a committee to serve with him and take up with the Superintendent of Highways, highway matters on which he advised having received complaints.

There being no further business, on motion and vete, the meeting adjourned to meet on Wednesday August 27th.1930 at 2 P.M.
