

Minutes of a Town of Riverhead Board meeting held by the Town Board of the Town of Riverhead at Town Hall, Howell Avenue, Riverhead, New York on Tuesday, August 20, 2013 at 7:00 p.m.

The meeting was opened at 7:00 p.m. by Supervisor Walter with Councilman Wooten leading the Pledge of Allegiance. Invocation was given by Rev. Mary Cooper, House of Praise Christian Revival Center, Riverhead.

Supervisor Walter announced that anyone interested in giving an Invocation can get in touch with Bill Seimers who is the coordinator through Temple Israel. He stated that if you cannot get in touch with Rabbi Seimers please call his office.

Supervisor Walter asked that Chris Witt and Bill Borges from the "Long Island Adventure Race" come to the front of the room. Councilman Gabrielsen explained that the Long Island Adventure recently held a survival race at EPCAL in which over a thousand people attended.

Long Island Adventure thanked the town of Riverhead for allowing them to run this event stating they look forward to working with the Town in the future. Chris also said they had two checks they wanted to present, one to the town of Riverhead in the amount of three thousand dollars and the other to PAL for a thousand dollars.

Chris and Bill again thanked the Board especially Councilman Gabrielsen who worked with them in setting up this event, for sticking with them and believing in them.

In turn Councilman Gabrielsen said that what makes this event so worthwhile is that Chris and Bill are local men who donated the proceeds back to Children's Hospital, Heidi Bear, North Fork Breast Collation, Manorville Fire Department and Riverhead Ambulance, just to name a view. Bill stated that collectively they have donated back approximately thirteen thousand dollars. Councilman Gabrielsen stated with young men like Chris and Bill Riverhead does have a bright future.

Supervisor Walter suggested that the three thousand dollars donated by Long Island Adventure Race the town should do something recreational with the funds. Councilman Gabrielsen responded by saying he was going to recommend to the Board that they reinvest that money back into the EPCAL site. Supervisor Walter responded by saying the Board wanted that donation to be earmarked for EPCAL.

Supervisor Walter asked that Ray Coyne from the Recreation Department come forward. Ray stated that last month a boat approximately two or three hundred yards off shore in the Sound overturned. He stated that lifeguards Charlie and Paul rescued three people, all whom could not swim, from the overturned boat. Ray thanked the lifeguards for doing the job they were trained to do stating that he knew it was not an easy job. Supervisor Walter also thanked them stating if not for them three people would possibly not be with us any longer. He also thanked them for a job well done.

On behalf of the Town Board Ray presented the young men with a proclamation thanking them for their life saving efforts on July 22, 2013.

Supervisor Walter now addressed the residents in the audience stating if anyone was here for the Knightland Resolution it was going to be tabled due to the temporary restraining order that was issued. He stated the Town Board would not be voting on that Resolution today and it would be tabled until the temporary injunction is lifted.

Councilman Dunleavy made a motion, seconded by Councilman Gabrielsen, to approve the minutes from the August 6, 2013 Town Board meeting. Motion carried, minutes were approved.

Councilman Gabrielsen announced that the Wildlife Management Committee from the town of Riverhead will be having a Bow Hunting lottery on Monday, September 16, 2013 at 7:00 p.m. The season for bow hunting will be from October 7, 2013 through December 1, 2013

COMMENTS ON RESOLUTIONS

Supervisor Walter: “Comments on Resolutions. Sal, how did we do?”

Sal Mastropaolo: “Good. Sal Mastropaolo, Calverton. Resolution #601. I just have a couple of questions. One is, who’s going to get involved from the Town of Poughkeepsie as far as interfacing with the other towns and how does the Peconic Bay Keeper interface with this situation?”

Supervisor Walter: “OK, why do you say Poughkeepsie?”

Sal Mastropaolo: “Oh, Riverhead.”

Councilwoman Giglio: “I’ve been the liaison for the Peconic Estuary Program and the Peconic Estuary Program Technical Advisory Committee and Drew Dillingham, the town engineer is handling the MS4 program and with the MS4 program under scrutiny from the New York State DEC where they’re going to make changes and pass down some more unfunded mandates so the towns felt it was important that we form a collation to be able to respond in a unified voice to the DEC with recommendations to the MS4 program that how Long Island can differentiate itself from upstate where they don’t necessarily have the same soil conditions that we have here in Suffolk County; so that’s why.”

Sal Mastropaolo: “Do you have any idea how much this is going to impact his time?”

Councilwoman Giglio: “It’s going to reduce, the time he spends on the Peconic Estuary Program?”

Sal Mastropaolo: “No the time he spends in other duties. I mean you’re approving seventy-five hundred dollars but you could also be approving forty thousand dollars’ worth of his time.”

Councilwoman Giglio: “Oh no, it will reduce the amount of time he spends on the Peconic Estuary Program significantly because there’s a tremendous amount of time that he dedicates to the MS4 program and the Peconic Estuary Program and now he can just send an email to the coordinator who will coordinate all of the responses from all of the townships that are participating and they will forward that information to the state.”

Supervisor Walter: “From a very practical standpoint, there are heavy fines associated with us not training and promoting and doing all the stuff for the Peconic Estuary and so from my personal perspective it’s almost like a self-imposed fine. We pay the seventy-five hundred,

we hope that they do the training, the outreach, the things and that when somebody turns to us and says well you didn't do it, we say well yeah we've been here."

Sal Mastropaolo: "Ok, Resolution 606. I guess I just have a couple of questions. One is where is the Accessory Apartment Committee located? I mean where do they reside? Do they reside in the Building Department?"

Supervisor Walter: "All of these people work for the Building and Planning Administrator, the Planning Director and his designee and the Building Administrator all work for Jeff Murphree so it's basically, we've combined, even though they're not all located at the Building and Planning Department, they all work within the Building and Planning Department."

Sal Mastropaolo: "So if you wanted to find out if someone had an accessory apartment permit you would go to where?"

Supervisor Walter: "The Building Department."

Sal Mastropaolo: "Ok. Another questions is, I don't see anything in here that speaks to the requirement that we used to have that an accessory apartment had to be in the main residence or if it was in a garage like the situation we had in Jamesport a couple of years back where the garage had to be attached to the house. Have we dropped that requirement about accessory apartments?"

Bob Kozakiewicz: "The size limits and the location, that particular part of the Accessory Apartment Review legislation is not being affected. That's why you don't see any language so whatever is currently in the code as far as the size of the accessory apartment, its limit to one bedroom that will remain the same."

Sal Mastropaolo: "Well that's in here though. I mean I saw that in the first couple of pages. I just see no reference whatsoever to where the apartment has to be located."

Councilman Wooten: "The whole entire code isn't here."

Sal Mastropaolo: "Well, ok. Thank you."

Supervisor Walter: "Does anyone else wish to be heard on Resolutions? Not seeing anybody, Diane?"

Councilwoman Giglio: "It doesn't have to be attached."

Sal Mastropaolo: "Say that again."

Councilwoman Giglio: "An accessory apartment doesn't have to be attached to main building, it never has."

Sal Mastropaolo: “But wait, if you go back about two years ago we had a situation in Jamesport where we had a town employee who put an apartment over his garage for his in-laws. I mean this came up quite a bit and we were going to force him to put up a forty foot breezeway and from what I understand he put up a breezeway to connect the garage to the house so it’s considered one unit and all I want to know is do we still have that requirement and you’re saying it doesn’t have to be in the main building.”

Councilwoman Giglio: “No.”

Sal Mastropaolo: “So you can have it in a detached garage with no breezeway connecting the two?”

Councilwoman Giglio: “That’s right and I think that should be changed. I think it should be part of the main building.”

Councilman Wooten: “I sat in on that meeting and I don’t think the issue was so much whether it was connected, it was the size. Well,”

Sal Mastropaolo: “I tell you there was quite a bit discussion as to whether he could build a forty foot breezeway between the house and the garage.”

Councilman Wooten: “It’s not there now.”

Supervisor Walter: “I think that predates my tenure on the Town Board.”

Councilwoman Giglio: “It might have been the square footage because if you have moresquare footage than you’re allowed to have in the code and you’re allowed to attach it to the main house then the square footage doesn’t matter but it’s limited if you’re going to have it detached from the main structure to the square footage.”

Sal Mastropaolo: “Ok. Thank you.”

The amended Resolution, the title is “Authorizes the Supervisor to Execute an Easement for Underground Utility Services to the Woolworth Building.” So we’re going to be pulling out electrical and natural gas, we’re combining 612 and 613. The first *whereas* will be the Woolworth revitalization LLC wishes to install new underground utility services to lay, maintain and operate electrical, natural and gas, and water Services to the former Woolworth building located at 130 E. Main Street, Riverhead, County of Suffolk, State of New York known as Suffolk County Tax Map No. 0600129-1-8.2 premises. The second *whereas* will be amended to say Woolworth Revitalization LLC proposes to enter into, under and across the property of the Riverhead Public Parking District number one to install new utilities services to the premises. The third *whereas* is the same. The fourth *whereas* will say “the Town Board finds that the installation of the utility services to the former Woolworth Building will enhance the reuse and redevelopment of the former Woolworth building. The first *Now and Therefore Be It Resolved* reads “That the Town Board acting on behalf of the Riverhead Public Parking District Number One beyond (inaudible) the premises where the utilities services to the former Woolworth Building are proposed, authorizes the grant of an easement to Woolworth Revitalization LLC. So we’re combining the gas and the electric services into one, gas and water rather into one utility easement. So, can I get someone to offer that as a Resolution amended?”

Councilwoman Giglio: “Resolution 612 Authorizes the Town to Execute an Easement Underground Utility Services to the Woolworth Building as amended by the Supervisor as prescribed. So moved.”

Councilman Dunleavy: “And seconded.”

Supervisor Walter: “Moved and seconded. Vote please.”

The Vote: Giglio, yes; Gabrielsen, yes; Wooten, yes; Dunleavy, yes; Walter, yes. Resolution adopted.”

Resolution #613

Councilman Wooten: “Resolution 613 is withdrawn, it’s been in cooperated with 612.”

Councilman Dunleavy: “I make a motion that we withdraw Resolution 613.”

Councilman Wooten: “I second it.”

Supervisor Walter: “Vote please.”

John Reeve: “Not to take the firewood, no.”

GENERAL COMMENTS

Supervisor Walter: “Ok. Now we open the public comment on anything that suits the residents fancy. We ask that you limit your comments to five minutes and hopefully it’s stuff within the purview of the town. If you would state your name for the record that would be wonderful.”

Clara Bennett from Oakwood Dr. Manorville stated she had two issues to discuss. The first issue was brought to the attention of Supervisor Walter in 2010 regarding the responders to her neighborhood. She asked if the responder was the Riverhead Ambulance District or the Manorville Ambulance District. She stated a neighbor’s daughter was choking and it took hours for the ambulance to respond to the call.

Supervisor Walter stated there have been numerous meetings between the two Districts and that one of the districts was moving very slowly on this matter. He said there has to be a mutual aid agreement between the Riverhead District and the Manorville District. He stated they would like the Riverhead District to take over the Peconic Estates just over the Riverhead line and that the Manorville District would help the areas where Ms. Bennett is which is Oakwood Drive.

Ms. Bennett asked what the community can do to speed up an agreement between the two Districts since this has been an ongoing issue for the past three years. Supervisor Walter responded that they, Ms. Bennett and her neighbors, should contact the ambulance boards and see if they have any open meetings that the residents could attend. He also suggested that a letter be sent to the Ambulance Board of Manorville and Riverhead adding that the Town Board of Riverhead is in support of this and that unfortunately the Boards hands are tied because this is a mutual aid. Supervisor Walter asked Chief Hegermiller to take the information from Ms. Bennett regarding the 911 call made regarding the little girl who was choking.

Ms. Bennett’s second issue concerned errors that are ongoing with the 911 system. She stated that her town’s name is incorrect. When the police department did a reverse dial up (at her request) to her home phone number, it came up as Calverton. She stated that the police cannot find her and her neighbors homes since the town is incorrect. Supervisor Walter stated he thought this issue was resolved at the recent meeting that was held in regard to this matter. He then asked the Police Chief to come to the podium to respond. Supervisor Walter asked if Chief Hegermiller could contact Verizon since they have the data base which determines areas. He also said this matter should be resolved immediately.

Supervisor Walter told Ms. Bennett he will call and set up a meeting with the Riverhead Ambulance District, the Manorville Ambulance District, himself and Ms. Bennett to find out when this situation can be settled.

Ms. Bennett introduced Cheryl Smith, a fellow resident of Oakwood Drive, who also had an incident concerning an ambulance response.

Ms. Smith wanted to know who was going to be Oakwood Drive's advocate in regard to this matter. She said at one time she was choking and it took the Riverhead Ambulance thirty-seven minutes to respond to her 911 call. She stated this was unacceptable.

Supervisor Walter agreed with her and Ms. Bennett and stated he would definitely look into this matter.

Bill Rower from St. Jamesport states he rents boating space at the town marina in South Jamesport. He wanted to notify the Board that safety is a major problem at that Marina. He stated that in April, while down at the Marina, he fell into the water fully dressed in winter type clothing. A gentleman who happened to be in the parking lot saved his life. He said there is no access out of the water if you should fall in like he did. He stated there are no ramps, no ladders, no way of getting up because of the cement docks. He also stated that the ring that was thrown to him had no rope for him to grab on to and was so small he could barely get it around himself. He said this matter was brought to the attention of the Recreation Department three times and three times he was told they were looking into it. He hoped this matter would be addressed as soon as possible.

Supervisor Walter said the rings should definitely have ropes attached and should be in sizes since everyone is not the same size and ladders should be attached to the dock.

Councilman Gabrielsen stated that since he is the liaison to the Recreation Department, he will speak to Ray Coyne about this matter. He asked that Mr. Rower leave his telephone number with Tara so he can inform him of his discussion with Ray.

Mr. Rower then stated that because there is no Dock Master to call in case of an emergency this matter should be addressed ASAP.

Councilman Dunleavy stated that public safety is something he stands behind and money should not be an issue. He also feels this matter should be addressed immediately.

Supervisor Walter: "Does anybody else wish to be heard? Can I get a motion to adjourn?"

Councilman Dunleavy: "I make a motion we adjourn this Town Board meeting."

Supervisor Walter: "All in favor?" Collective ayes.
