**WHEREAS**, by Resolution #25 dated March 20, 2006, the Riverhead Planning Board adopted a resolution conditionally approving the final plat of the subdivision entitled, "Calverton Camelot II", filed by M-GBC, LLC; and

**WHEREAS**, the aforementioned resolution requested that M-GBC, LLC post a performance bond or other security in the amount of \$3,000,000.00 representing road and drainage improvements to be completed within said subdivision; and

**WHEREAS**, M-GBC, LLC has submitted to the Town, Suffolk County National Bank Irrevocable Letter of Credit #061130 in the amount of Three Million and 00/100 (\$3,000,000.00) Dollars for improvements to be completed within said subdivision; and

**WHEREAS**, the Town Attorney has reviewed said irrevocable letter of credit and determines same to be acceptable in connection with the improvements to be completed in the subdivision entitled, "Calverton Camelot II".

**NOW THEREFORE BE IT RESOLVED**, that the Town Board of the Town of Riverhead hereby accepts Suffolk County National Bank Irrevocable Letter of Credit #061130 in the amount of Three Million and 00/100 (\$3,000,000.00) Dollars for improvements to be completed within said subdivision; and be it further
