PLEASE TAKE NOTICE that a special meeting of the Town Board of the Town of Riverhead and the Community Development Agency (CDA) will be held at Riverhead Town Hall, 200 Howell Avenue, Riverhead, New York, on Tuesday, September 13th at 10:00 a.m. for the purpose of consideration of the following resolution:

A RESOLUTION CALLING A PUBLIC HEARING ON THE TOWN OF RIVERHEAD, AS LEGISLATIVE BODY FOR THE TOWN OF RIVERHEAD AND GOVERNING BODY OF THE COMMUNITY DEVELOPMENT AGENCY, DESIGNATION OF JOINT VENTURE ENTITY BETWEEN RXR REALTY (“RXR”) AND GEORGICA GREEN VENTURES (“GGV”) (PREVIOUSLY DESIGNATED “MASTER DEVELOPER”) AS A QUALIFIED AND ELIGIBLE SPONSOR FOR THE PURCHASE AND DEVELOPMENT OF 2+-ACRE TOWN-OWNED PROPERTY (SCTM# 0600-128-3-LOTS 001.00 THROUGH 011.00) LOCATED ON COURT STREET AND TRANSFER OF ALL OR A PORTION THEREOF OF AND REDEVELOPMENT OF TWO PARCELS OWNED BY THE COUNTY OF SUFFOLK LOCATED ON GRIFFING AVENUE (SCTM#S 0600-128.00-05.00 LOTS AND 001.000 AND 002.000)

- 1) Name; 2) Hamlet; 3) Public Hearing, Resolution and/or Open Comment Topic.

If you are calling in, please dial *9 to “raise your hand”, so we can acknowledge your request to speak.

When it is your turn to speak, your status will be temporarily changed so you can be unmuted and visible for the five-minute comment period. After five minutes, you will be placed back in the audience.
